My Classified tree farm (since 2002) documents are already filed on this commission's docket and I have already been forced to fill out 2 duplicate farm exemption forms in 3/2024 & again in Sept. 19 2025, which should have been on file since 2005 when I wrote a check for 525\$ original meter also on this docket. My third meter is sitting dormant (zero piping) just like in (2008-2009 billing loop & late fees) because it was installed a year ahead of my request in stealth...so South Eastern Water 💧 association is not applying the tariff mandated minimum bill yet because I was UPSET, according to law firm STOLL. KEENON. OGDGEN.PLLC statements on this tribunal which is actually a true statement this time. I talked with Morris Vaughn personally on the phone about the early installation & possible bills.
