Dear Robert:

Thank you for following up regarding the regulatory requirement, set forth in Commitment No. 10 of Appendix C to the September 30, 2010 Order entered in Case No. 2010-00204, that Louisville Gas and Electric Company (LG&E) and Kentucky Utilities Company (KU) schedule CEO meetings with the Commission and its staff twice per year. As you noted, since 2010 the Commission has been in agreement to meet only once per year, and the most recent meeting was held on April 3, 2018.

Please be advised that the Commission has reevaluated this requirement and determined that, absent any pressing need for a CEO discussion to be held, such meetings with the Commission and its staff need only occur once every two years. Since the Commission and its staff last met with executives from PPL Corporation, LG&E and KU in 2018, the next meeting to be scheduled per the requirements in Case No. 2010-00204 should be scheduled in 2020.
