On August 26, 2010, an informal conference ("IC") convened in this case at the Commission's offices was attended by representatives of Kentucky Utilities Company, Louisville Gas and Electric Company ("KU/LG&E"), PPL Corp. ("PPL"), the Attorney General of the Commonwealth of Kentucky, The Kroger Company, Kentucky Industrial Utility Customers, Inc., Association of Community Ministries, International Brotherhood of Electrical Workers 2100, the Kentucky School Board Association, Big Rivers Electric Corporation, Community Action Council of Lexington-Fayette, Bourbon, Harrison and Nicholas Counties, Lexington-Fayette Urban County Government, Kentucky Resources Council, Metro Housing Coalition, and Commission Staff. Attendance lists for the last two days of the IC are attached hereto.

The purpose of the IC was to discuss possible settlement of the issues in this case regarding the acquisition of KU/LG&E by PPL. The IC was reconvened on August 27, 2010 and again of August 30, 2010. At the conclusion of the IC, the parties had reached a unanimous settlement resolving the issues in the case. The settlement was filed with the Commission on September 7, 2010.

With agreement in principle of the terms of the settlement, the IC was adjourned.
