**Code 336**

Relocate a section of existing .4 miles of three phase #336.4 ACSR and place taps of single phase off the main line totaling 1.6 miles of 1/0 STR Al and serving 13-100 kVA transformers. The new apartment complex is located near the corner of West Vine and Logsdon Parkway in Vine Grove, Kentucky.

Reason for change

The new apartment complex is Phase 1 of The Parks of Vine and will add approximately 78 members. The line will provide a better balance of the phases, improve outage time from trees and provide for future development of the other Phases.

**Code 337**

Tap an existing three phase #336.4 ACSR with 0.4 miles of a three phase 4/0 Al STR AL URD and place taps of single phase off the main line totaling 0.6 miles of 1/0 STR Al and serving 8 transformers of multiple size and configurations. The new complex is located near the corner of Ring Road and Tunnel Hill Road in Elizabethtown, Kentucky.

Reason for change

The new complex will add approximately 78 members. The line will provide a better balance of the phases, improve outage time from trees and provide for future development of the other Phases.

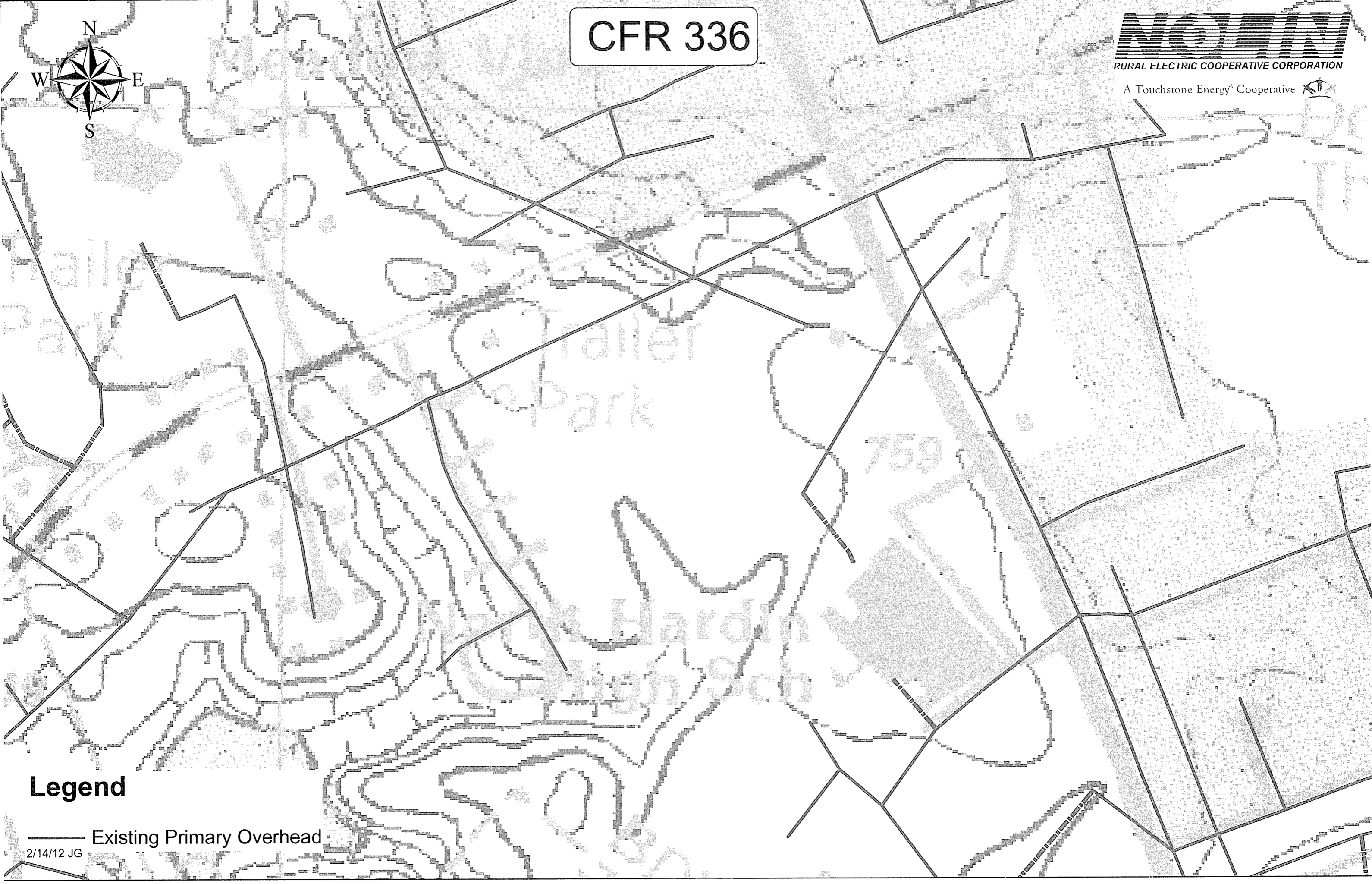
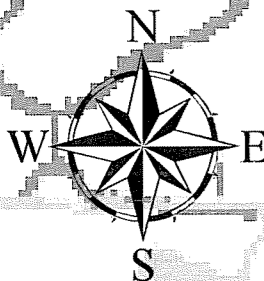

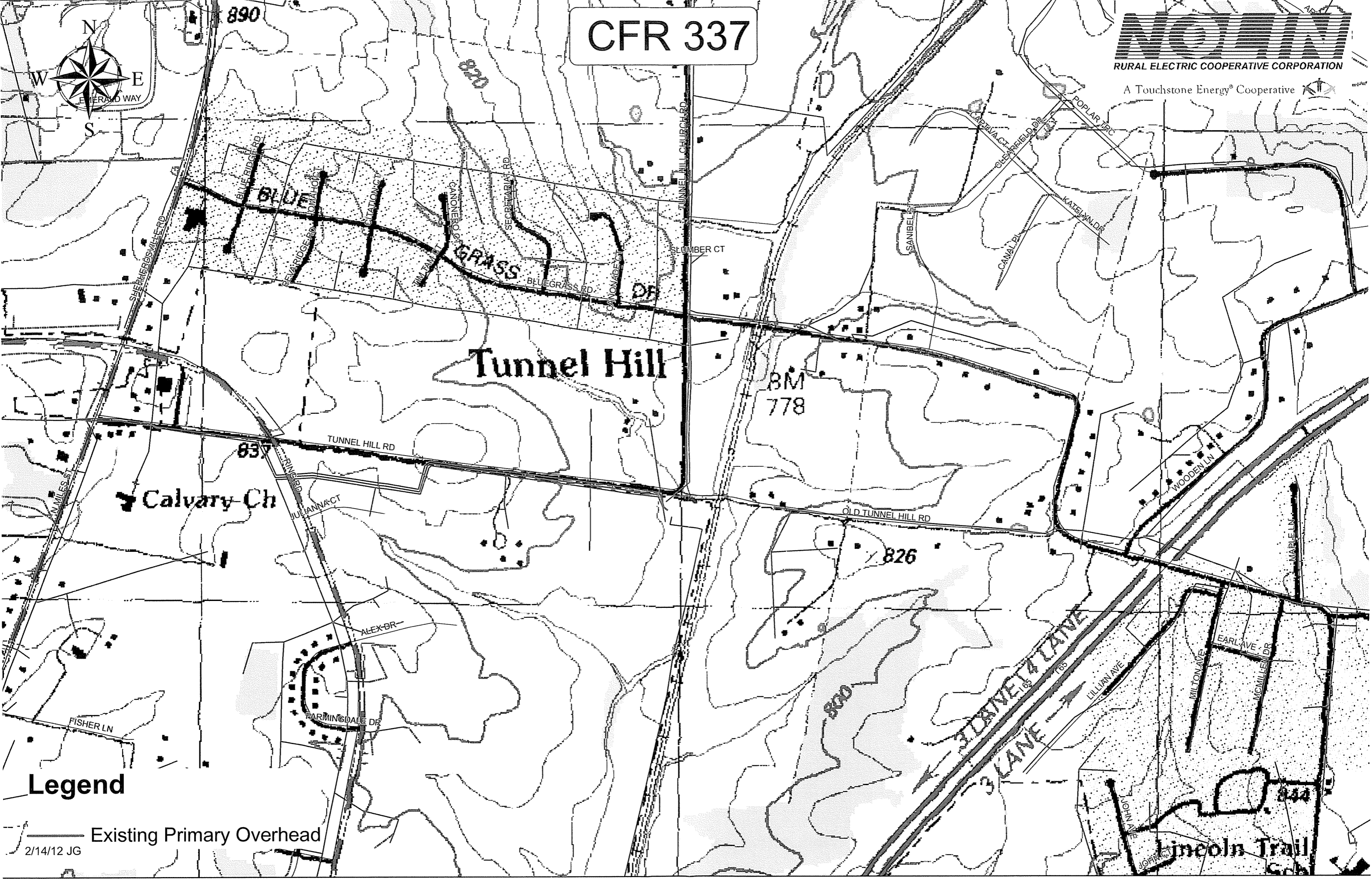
