APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE COMMISSION IN CASE NO. 2014-00426 DATED DEC 2 2 2014

- 1. In Case No. 2014-00319,¹ ordering paragraph 3, the Commission directed Citipower to file certain information concurrent with its GCR application for rates effective January 1, 2015. Explain why Citipower failed to provide the information as requested.
- State whether Citipower bills all of its customers subject to the GCR rate on the same date each month, or whether Citipower uses cycle billings.
- a. If Citipower bills all of its customers on the same date, provide the date of the month Citipower bills its sales customers subject to the GCR rate.
- b. Provide a copy of monthly bills for one customer for each of the months of January 2014 through December 2014. Ensure that all personal information, including name, address, account numbers, etc., has been redacted.
- c. If Citipower uses cycle billing, provide the dates of each of the billing cycles for the months of January 2014 through December 2014. The response should include the billing period and the billing date for each cycle.
- 3. Explain how customer bills and Citipower's recovery of gas cost are affected by the approval of the GCR rate after the proposed effective dates in Case Nos. 2014-00071² and 2013-00433.³
