

Dear Mr. Lovekamp:

This is to acknowledge that your letter, dated May 31, 2018, on behalf of Louisville Gas and Electric Company and Kentucky Utilities Company (jointly "Companies"), has been filed in the post-case reference file for Case No. 2015-00355. In that case, the Commission approved initial rates and tariffs applicable to electric vehicle charging and equipment. Your letter states that revisions to those rates were approved by the Commission in 2017 in the Companies' last base rate cases, and you request to again revise those rates in 2019 as part of the Companies' next base rate cases to be filed later this year. Commission Staff notes that while the April 11, 2016 Final Order in Case No. 2015-00355 referenced the Companies intent to annually file revisions to those rates, that Order did not require the annual filing of revised rates. Commission Staff appreciates your advance notice regarding the timing of revisions to the electric vehicle rates.
