



Dear Chairman and Members of the Kentucky Public Service Commission:

I am writing as a concerned citizen to submit a formal comment on Case No. 2020-00391, regarding Henderson County Solar LLC (also known as Henderson Solar, LLC), and to highlight a potential irregularity in the local approval process that may affect the validity of the project's site plan extension.

On July 1, 2025, the Henderson City-County Planning Commission approved a one-year extension of the site plan for this project. However, Commission member Gray Hodge participated in and voted for this extension, despite an apparent conflict of interest under Kentucky Revised Statutes (KRS) 100.171. Mr. Hodges' wife (Nancy Hodge) owns Leo King Farms LLC, which has solar contracts or leases tied to projects in the Robards area, such as the Sebree Solar project. This constitutes an indirect financial interest, as local decisions on solar developments could influence the family's financial stakes in similar

projects.

KRS 100.171 requires planning commission members to disclose such interests and recuse themselves from voting. Failure to do so may invalidate the local approval, which is a prerequisite or related step for PSC-reviewed projects. The project in Case No. 2020-00391 has seen ownership changes (e.g., to AES and then Stellar Renewables) and has not yet filed a final site plan, making the local extension critical.

I respectfully request that the Commission:

1. Investigate the potential conflict of interest in the local planning commission's approval process.
2. Consider whether the site plan extension should be deemed invalid due to the violation of KRS 100.171.
3. Hold a public hearing or solicit additional input on this matter to ensure transparency and compliance with state ethics laws.
4. Incorporate this comment into the official case record.

Thank you for considering this information as part of your review. Maintaining public confidence in the regulatory process is essential, and I appreciate your commitment to fair oversight. I am available for any further clarification.
