**Re: Name Change for Eligible Telecommunications Carrier Designation
Case No. 2023-00079**

Dear Commission:

Pursuant to communications with Commission staff, DISH Wireless L.L.C. (“DISH Wireless”) and its successor affiliate, Boost SubscriberCo L.L.C. (“Boost SubscriberCo”), respectfully request that the Kentucky Public Service Commission (“Commission”) update its records to reflect Boost SubscriberCo L.L.C. d/b/a Gen Mobile as the name under which the Eligible Telecommunications Carrier (“ETC”) designation for Lifeline purposes is held in the State of Kentucky.

DISH Wireless and Boost SubscriberCo are wholly owned, indirect subsidiaries of EchoStar Corporation (“EchoStar”). Boost SubscriberCo is ultimately owned and controlled by EchoStar, which also owns and controls DISH Wireless. EchoStar recently completed an internal, *pro forma* corporate reorganization pursuant to which certain assets, including the Gen Mobile brand, were transferred from DISH Wireless to Boost SubscriberCo. This internal reorganization did not result in a change in control.

The reorganization did not result in any changes to Gen Mobile’s operations or any customer-facing aspects of the business. Specifically:

- Day-to-day operations and personnel providing oversight remain unchanged;
- Customer service protocols and contact information remain unchanged;
- There is no impact on Gen Mobile’s ability to serve customers or the quality of service provided;
- Lifeline service rates, terms, and conditions remain unchanged; and
- Lifeline services will continue to be offered under the “Gen Mobile” brand name.

Boost SubscriberCo L.L.C. assumes and will continue to comply with all applicable federal and state laws and Commission rules relating to ETC designation and Lifeline service, including all obligations, conditions, and requirements set forth in the Commission’s ETC designation order issued on October 17, 2023 in Case No. 2023-00079.

Further, Boost SubscriberCo is authorized to conduct business in Kentucky.

Given the *pro forma* nature of the internal reorganization and the continuity of ownership, control, and operations, DISH Wireless and Boost SubscriberCo respectfully request that the Commission update its ETC Designation records to reflect Boost SubscriberCo L.L.C. d/b/a Gen Mobile as the holder of the ETC designation effective immediately.

We appreciate the Commission's attention to this matter and are available to provide any additional information the Commission may require.
