When a Cooperative representative calls at a members premises for the purpose of collecting a delinquent bill, it will be assessed when:

- The service is terminated
- Member pays the delinquent bill
- Member agrees to a payment schedule

A maximum of one (1) collection fee will be assessed a member within a single thirty (30) day period.

32. RECONNECTION FEE - \$37.50 DURING REGULAR OFFICE HOURS  
- \$47.50 OUTSIDE REGULAR OFFICE HOURS

Applicable to services which have been disconnected due to non-payment. Due and payable at the time of reconnection.

33. LATE PAYMENT PENALTY - 10% OF NET AMOUNT

10% of net amount due will be assessed if member fails to pay the net amount by the 15th of the month. A penalty may be assessed only once on any bill for service rendered.
