### RATES

- 1. Capacity
  - a. \$50.36 per kW per year is applicable if cogenerator or small power producer is (I) dispatched by EKPC.
  - b. \$0.005851 per kWh is applicable if cogenerator or small power producer is not (R) dispatched by EKPC.
  - 2. Energy A base payment per kWh is listed below for a time-differentiated basis or a nontime differentiated basis for the specified years.
