Dear Ms. Smith:

This letter constitutes the bid of Owen Electric Cooperative, Inc., ("Owen"), a Kentucky non-stock corporation engaged in the distribution of electricity at retail, for the acquisition of a franchise as referred to in an Ordinance of the City of Sparta, Gallatin County, Kentucky, for the right and privilege of installing in and upon the public streets, alleys and grounds of the City, fixtures and equipment for the transmission and distribution of electricity and providing for the manner in which said facilities shall be installed, maintained and operated. Owen requests that the franchise be for a term of twenty (20) years. Owen submits a bid of \$1.00 for the franchise referred to herein. As additional consideration for the grant of the franchise, Owen will collect and pay to the City a sum equal to 3% of the gross revenue received by Owen, on and after the date when the grant of the franchise becomes effective and approved by the Kentucky Public Service Commission ("PSC"), from electric service rendered within the corporate limits of the City to customers supplied under residential and commercial revenue classifications as now defined in Owen's system of accounts and reported to the Kentucky PSC.
