3. All wiring, pole lines and other electrical equipment beyond the metering point, exclusive of the service transformers and protective equipment, is considered the distribution system of the consumer and shall be furnished and maintained by the consumer.

4. Service will be rendered only under the following conditions:

(a) An "Agreement for Purchased Power" shall be executed by the consumer for service under this schedule.

(b) The consumer shall guarantee a minimum annual revenue of not less than 18% of the estimated additional investment required to extend service, which shall include the additional cost of meters, transformers and any additions to or alterations of line and equipment necessary to make service available. Minimum charges for service shall be based on the additional investment only when this results in greater than those based on the KVA of installed transformers capacity.
