PUBLIC SERVICE COMMISSION

AN ORDINANCE AMENDING CDO SECTION 18-79, ENTITLED "WATERWORKS AND WATER DISTRIBUTION", REDUCING WATER RATES FOR CERTAIN WHOLESALE AND INDUSTRIAL CONSUMERS.

WHEREAS, the Board of Commissioners deems it necessary and appropriate to make certain adjustments in the water rates charged to wholesale consumers and certain industrial consumers;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF DANVILLE, KENTUCKY, AS FOLLOWS:

SECTION ONE: CDO Section 18-79, entitled "Waterworks and water distribution", is hereby amended to read as follows:

"There is hereby adopted, established and ordained, and there shall be collected as revised schedule of rates and charges for use of the services and facilities rendered by the municipal waterworks and water distribution system, except as otherwise provided by contract, as follows:

(1) Monthly water rates for residential and commercial consumers.

The minimum monthly rate is four dollars and five cents (\$4.05) plus sewer charge.
