**RULES AND REGULATIONS**

**6.02.03 ELEVATED SERVICE AREA SURCHARGE**

All customers shall pay a surcharge of \$0.27 per thousand gallons if water must be delivered at a higher elevation than the general pressure plane served by the Crescent Hill/Cardinal Hill System, excluding customers in the Kentucky Turnpike #2, Goshen Utilities, and Shepherdsville services under one (1) inch areas.

**6.03 WHOLESALE CUSTOMERS**

Wholesale customers which purchase water for resale wherever situated shall be charged: \$ 1.44 per thousand gallons for all water purchased, the elevated service area surcharge specified in Rule 6.02.3 If applicable, and the service charge specified in Rule 6.02.1. For 2007 these rates will go into effect for water service on and after May 1, 2007.

**MINIMUM CHARGE**

**DELAY CHARGE**

In the event that payment for any charge is not made within twenty (20) days from the billing date, the the net amount of the bill shall be increased by 5% and the gross amount thus determined must be paid.
