**RULES AND REGULATIONS**

**6.02.03 ELEVATED SERVICE AREA SURCHARGE**

All customers shall pay a surcharge of \$0.30 per thousand gallons if water must be delivered at a higher elevation than the general pressure plane served by the Crescent Hill/Cardinal Hill System, excluding customers in the Kentucky Turnpike #2.

**6.03 WHOLESALE CUSTOMERS**

Wholesale customers which purchase water for resale wherever situated shall be charged: \$1.80 per thousand gallons for all water purchased, the elevated service area surcharge of \$0.30 per thousand gallons, if applicable, and the service charge shall be charged in accordance with specified in Rule 6.02.01.

MINIMUM CHARGE N/A

**DELAY CHARGE**

In the event that payment for any charge is not made within twenty (20) days from the billing date, the net amount of the bill shall be increased by 5% and the gross amount thus determined must be paid.
