AMENDMENT TO AGREEMENT DATED MAY 14, 1992

This Amendment to Agreement (the "Amendment") is entered into as of the <u>Ist</u> day of <u>December</u>, 2008, by and between the City Utility Commission of the City of Owensboro, Kentucky, also known as Owensboro Municipal Utilities (hereinafter "OMU"), of 2070 Tamarack Road, Owensboro, Kentucky 42301, and West Daviess County Water District of 3400 Bittel Road, Owensboro, Kentucky 42301, a water district organized under the provisions of KRS Chapter 74 by order of the Daviess County Fiscal Court (hereinafter "DISTRICT"):

WITNESSETH

WHEREAS, OMU is authorized by the Statutes of Kentucky and/or by the Ordinances of the City of Owensboro, Kentucky, to own, operate, and maintain a water system within and beyond the City limits of Owensboro; and,

WHEREAS, the DISTRICT is organized under the laws of Kentucky and the orders of the Daviess County Fiscal Court to operate a water district for the purpose of supplying water within said DISTRICT; and,

WHEREAS, OMU and the DISTRICT (hereinafter collectively referred to as "Parties") have agreed upon the terms and conditions under which OMU shall sell and the DISTRICT shall purchase water to be distributed by the DISTRICT to its customers; and,

WHEREAS, OMU and the DISTRICT have previously entered into a Contract dated May 14, 1992 (hereinafter "Agreement"), PUBLIC SERVICE COMMISSION under which Ker PUSKICT EFFECTIVE 2/7/2009 PURSUANT TO 807 KAR 5:011

SECTION 9 (1)

WHEREAS, the Parties wish to amend the term of said Agreement by entering into this Amendment.

NOW, THEREFORE, in consideration of the premises and the mutual covenants contained herein, it is covenanted and agreed between the parties hereto as follows:

1. ARTICLE II, Section 2.1 is hereby amended to now read as follows:

"<u>2.1 Term</u>

This Agreement shall continue in full force and effect until May 31, 2038, unless sooner terminated under the terms of this Agreement."

2. All other terms to the Agreement dated May 14, 1992 shall remain in full force and effect, except as expressly modified, replaced or eliminated herein.

3. This Amendment shall become effective upon proper execution by both of the Parties and approval of the Amendment by the City of Owensboro.
