IT IS HEREBY AGREED by and between the City of Somerset and the Pleasant Hill Water District, that the terms of the existing Contract for purchase of treated water between both parties as executed on the 21st day of July, 1969, be amended as follows:

1. The City of Somerset is the successor in interest to Kentucky Water Service Company, Inc. by way of the asset purchase of the Kentucky Water Service Company, Inc. by the City of Somerset in a contract dated the 23rd day of December, 1985.

2. Water District has obtained a loan in the amount of \$632,000.00 from Farmers Home Administration, a facility of the U.S. Department of Agriculture, evidenced by Promissory Note, secured by Mortgage on plant facilities and pledge of certain revenues to the Farmers Home Administration payable over a period of forty (40) years from the date of said loan.

3. The water will be furnished at an existing sixteen inch main at a point located on South Highway 27 near the entrance to Shearwood Subdivision in Pulaski County, Kentucky.

4. The City of Somerset shall own and operate all facilities leading to and including the Master Meter, and the Pleasant Hill Water District, shall own and operate all facilities on the discharge side of the Master Meter.

This document does not in any way other than the terms set out herein, amend, repeal, or affect any of the terms, conditions and provisions of said Contract for purchase of treated water of the 21st day of July, 1969.
