

ADDENDUM II TO WATER PURCHASE CONTRACT

THIS ADDENDUM to the Water Purchase Contract, and prior Addendum thereto, by and between the parties, said Contract and Addendum being dated January 2, 1999 and June 21, 2001, respectively, made and entered into this the 4th day of November, 2002, by and between the CAMPBELLSVILLE MUNICIPAL WATER AND SEWER SYSTEM, Campbellsville, Kentucky, hereinafter referred to as "SELLER" and the GREEN-TAYLOR WATER DISTRICT, of Industrial Park Road, Greensburg, Kentucky, hereinafter referred to as "PURCHASER."

WHEREAS, by action of its Board of Commissioners on the \_\_\_ day of \_\_\_, 2002, to be executed through the General Manager, by the SELLER it was agreed to extend the Water Purchase Contract to sell water to the district for an additional period of ten (10 ) years, through and including the year of 2049, and in accordance with the provisions of said Resolution this Addendum was approved, and the execution of this Addendum carrying out the said resolution by the authorized officers of SELLER, and attested by the Secretary, was duly authorized, and

WHEREAS, by resolution enacted on the 4th day of November, 2002, by the PURCHASER, it was agreed to purchase water and to extend the Water Purchase Contract for an additional period of ten (10 ) years, through and including the year of 2049, and in accordance with the provisions set forth in said Resolution this Addendum was approved, and the execution of this Addendum the Chairman, attested by the Secretary, was duly authorized.

NOW THEREFORE, for and in consideration of the foregoing and the mutual agreement hereinafter set forth, the SELLER and the PURCHASER agree as follows:

- 1. This Addendum shall extend the Water Purchase Contract dated January 2, 1999, and the Addendum thereto dated June 21, 2001, between SELLER and PURCHASER for an additional period of ten (10 ) years, through and including the year of 2049, and



thereafter may be renewed or extended for such term, or terms, as may be agreed upon by SELLER and PURCHASER,

- 2. All other provisions of the Water Purchase Contract dated January 2, 1999, and the aforesaid prior Addendum thereto, are to remain in full force and effect.

**IN WITNESS WHEREOF**, the parties hereto, acting under the authority of their respective governing bodies, have caused this Addendum to be duly executed in three (3) counterparts, each of which shall constitute an original.
