

## WATER LINE EXTENSION AGREEMENT

This water line extension agreement is made and entered into this the 14TH day of April, 1996, by and between Robert L. Brown and Glenda P. Brown (Developers) and Tri-Village Water District (Tri-Village), all of Owen County, Kentucky.

## WITNESSETH:

That whereas Tri-Village owns and operates a treated water distribution system in Owen County, Kentucky; and

Whereas the Browns have constructed a water line along know as the Scott Farm to service certain real estate they are developing; and

Whereas the Brown's line runs on this property on two private roads.

Whereas the Browns have agreed that upon the expiration of one year from the time said water line is put into operation, and upon inspection or testing by Tri-Village to insure that the water line is free of leaks and defects in its construction, Tri-Village shall assume ownership and maintenance of same; and

Whereas the parties have reached and agreement by which the Browns are paying all costs in construction of the water line; and

Whereas the parties desire to reduce their agreement regarding said water line to writing; now

Therefore, upon the terms and conditions contained herein, the parties hereto agree as follows:

- 1. That one year from the beginning of the operation of the Brown's waterline, Tri-Village shall acquire ownership of the Brown's water lines, subject to satisfactory inspections of said lines by Tri-Village.
- 2. That in addition to ownership of the water lines, the Browns shall convey to Tri-Village a permanent easement for the maintenance, repair, and replacement of the water line.
- 3. That this agreement is entered into subject to the applicate COMMISSION OF KENTUCKY the U.S.D.A.-Fm.H.A. and the Natural Resources Cabinet, Division of EFFECTIVE Water.
