RATES AND CHARGES

LEAK ADJUSTMENT TARIFFS

All previous rates, regulations, and/or tariffs relating to the District's rate adjustment for leaks are void as of the effective date of this tariff.

From the effective date of this tariff, forward, the Policy of the North Mercer Water District concerning a customer request for a rate adjustment due to a leak shall include the following provisions:

1. Leaks eligible for a rate adjustment consideration shall be defined as a line break that is on the customer's side of the water meter that results in the excess of 10,000 gallons above the customer's average water usage from the previous 12 months.
2. All leaks must be proven. Any of the following may be used to prove that a leak existed:
  - a. Receipts for repair supplies
  - b. Pictures of the break
  - c. A plumber's statement
3. Customers must also bring in a signed statement by the person who completed the repair outlining how and when the repair was completed.
4. Customers will be limited to adjustments for one leak per year.

Due diligence must be required of customers that have received notice from the District of a potential leak and the time that the leak is repaired. Repairs that are not performed in a reasonable time after the determination that a leak exists will not be given consideration for a rate adjustment.

Should the District manager determine that a rate adjustment is appropriate for a reported leak, and all the above requirements met, an adjustment will be made to the customer's bill for the leak as outlined above with the excess water used discounted by \$1.00 per thousand gallons off the current rate.

Any customer dissatisfied with the decision of management may ask for a Board of Commissioners' Review.

Credit /Debit Cards.

All customers may pay their bill by credit or debit card. This method of payment may be made in person at the utility office or by telephone.

If on the bill due date an attempt to pay the credit card or debit card is made and the card is declined for any reason, payment is still due in full on that date and will be considered late after that date. All late charges and penalties will be applied. If a customer is paying on our disconnect day and the card is denied, the same rules as above apply, in addition to service being disconnected.

When a customer makes a payment by credit or debit card, the utility will assess a fee equal to that charged to the utility by the credit or debit card processing company to process the transaction. This fee is generally calculated using a formula applied to the balance of the amount charged to the credit or debit account but may be a flat fee per transaction.

Prior to processing the transaction, the customer will be informed of the fee amount and, upon request by the customer, the formula employed to arrive at this fee amount.

No employee or individual director of the Utility is permitted to make an exception to Rates, Rules or Regulations. All Rules and Regulations are to be in effect so long as they are not in conflict with Public Service Commission Rules and Regulations. The Utility is further subject to all Rules and Regulations of the Commission even though not contained herein.

REVISIONS

These Rules and Regulations may be revised, amended, supplemented or otherwise changed from time to time subject to approval of the Public Service Commission, and shall have the same force as the present Rules and Regulations.

SERVICE AREA

The Utility furnished water service to water customers located in North and East section of Mercer County, Kentucky.

NOTICE OF TROUBLE

Consumer shall give immediate notice to the Utility of any irregularities or unsatisfactory service and of any defects known to consumer.

MAINTENANCE

The Utility may at any time deemed necessary, suspend water service to any customer or consumers for the purpose of making repairs, changes or improvements upon any part of its system. The Utility shall give reasonable notice of such suspension of service to the consumer.

The Utility shall be responsible for the maintenance of that portion of the service line installed by the Utility and the consumer shall be responsible for the maintenance of that portion thereof installed by the consumer.

EXTENSION OF SERVICE

Extension of service shall be in accordance with 807 KAR 5:066E, Section 12.

LINE RELOCATIONS

When necessary to move or relocate facilities, the cost will be paid by party or parties requesting such relocation.

BILLING, COLLECTION, PENALTIES

Bill for water service furnished by the water system will be mailed no later than the First day of each month and will be due and payable within ten days. A 10% payment penalty charge will be applicable after the Fifteenth day of the month.

RULES AND REGULATIONS

**DISCONTINUANCE OF SERVICE BY UTILITY**

North Mercer Water District's regulation effective September 23, 1985, relating to discontinuance of service by utility is void.

The Utility may refuse or discontinue service to an applicant or customer, after proper notice, for failure to comply with its rules and regulations or state and municipal rules and regulations, when a customer or applicant refuses or neglects to provide reasonable access to the premises, for fraudulent or illegal use of service, or for nonpayment of bills. If discontinuance is for non-payment of bills, the customer shall be given at least 120 hours [five days] written notice, separate from the original bill, and cut-off shall be effected not less than twenty (20) days after the mailing date of the original bill unless, prior to discontinuance, a residential customer presents to the utility a written certificate, signed by a physician, registered nurse, or public health officer, that such discontinuance will aggravate an existing illness or infirmity on the affected premises, in which case discontinuance may not be effected until the affected resident can make other living arrangements or until not less than thirty (30) days elapse from the date of the Utility's notification. When a dangerous condition is found to exist on the customer's or applicant's premises, the service shall be cut off without notice or refused.

CONNECTION CHARGES

In addition to the connection charges previously approved by the District and the Public Service Commission on July 6, 1999, the District shall require each Customer to enter into a Water User Contract as promulgated by the District, which Contract shall state, inter alia, "[t]he Customer agrees that after the Water District has installed the water meter, the Customer shall pay the water bill according to applicable rates and tariffs; provided, however, if Customer does not desire water service, the Customer shall pay the minimum bill for twelve (12) months, at least, before the water meter is removed. The Customer agrees to pay the minimum water bill for twelve (12) months if the water meter, at the request of the Customer, is not installed. The Customer shall pay all appropriate charges for removal of the meter and/or reinstallation of the meter and security devices."

Any city, county, urban-county, charter county, fire protection district, or volunteer fire protection district ("User") may withdraw water from the utility's water distribution system for fighting fires or training firefighters at no charge on the condition that it maintains estimates of the amount of water used for fire protection and training during the calendar month and reports the amount of this water usage to the utility no later than the 15<sup>th</sup> day of the following calendar month.

Any User that withdraws water from the utility's water distribution system for fire protection or training purposes and fails to submit the required report on water usage in a timely manner shall be assessed the cost of this water. A User shall submit a monthly report even if it withdraws no water for fire protection or training purposes.

A non-reporting User's usage shall be presumed to be 0.3 percent of the utility's total water sales for the calendar month. A non-reporting User may present evidence of its actual usage to rebut the presumed usage. The utility shall consider this evidence and shall adjust the presumed usage amount accordingly.

The non-reporting User shall be billed for this usage at the lowest usage block rate regardless of customer classification that the utility charges.

A non-reporting User shall also be assessed a penalty of \$ 25.00 for each failure to submit a report in a timely manner.



MONITORING OF CUSTOMER USAGE

At least once annually the Company will monitor the usage of each customer according to the following procedure:

- 1. The customer's annual usage for the most recent 12-month period will be compared with the annual usage for the 12 months immediately preceding that period.
2. If the annual usage for the two periods are substantially the same or if any difference is known to be attributed to unique circumstances, such as unusual weather conditions, common to all customers, no further review will be done.
3. If the annual usages differ by 50 percent or more and cannot be attributed to a readily identified common cause, the Company will compare the customer's monthly usage records for the 12-month period with the monthly usage for the same months of the preceding year.
4. If the cause for the usage deviation cannot be determined from analysis of the customer's meter reading and billing records, the Company will contact the customer by telephone or in writing to determine whether there have been changes such as different number of household members or work staff, additional or different appliances, changes in business volume, or known leaks in the customer's service line.
5. Where the deviation is not otherwise explained, the Company will test the customer's meter to determine whether it shows an average error greater than 2 percent fast or slow.
6. The Company will notify the customers of the investigation, its findings, and any refunds or backbilling in accordance with 807 KAR 5:006, Section 10(4) and (5).

In addition to the annual monitoring, the Company will immediately investigate usage deviations brought to its attention as a result of its on-going meter reading or billing processes or customer inquiry.

**APPLICATIONS FOR WATER MAIN EXTENSIONS TO  
PROPOSED REAL ESTATE DEVELOPMENTS**

I. APPLICABILITY. This section shall apply to requests for water service to proposed real estate developments.

II. APPLICANT'S RIGHT TO DESIGN AND CONSTRUCT THE MAIN EXTENSION. An Applicant desiring a water main extension to an existing or proposed real estate development may elect to design and construct the proposed main extension or to contract with the Water District for the design of these facilities.

III. RESPONSIBILITIES OF AN APPLICANT. An Applicant for water service to a proposed real estate development shall have the following responsibilities:

A. If the Applicant is assuming responsibility for the design of the proposed water distribution main:

1. At the time of submitting its application, Applicant shall execute an "Agreement for Water Main Extension to Serve a Real Estate Development" similar in form and content to that shown in Appendix A.

2. Applicant shall provide the Water District or its designated representative with all preliminary plans and specifications of the proposed water main extension and any other documents as reasonably necessary to review Applicant's request for service. All preliminary plans and specifications shall be prepared by a professional engineer who is licensed to practice engineering in the Commonwealth of Kentucky.

3. Applicant shall make all reasonable modifications to the plans and specifications of the proposed water distribution main extensions that the Water District or its designated representative requests and that are reasonably necessary to ensure the quality and reliability of water service or the Water District's operational efficiency and integrity and that are consistent with accepted engineering standards.

4. Prior to its submission of final plans and specifications for the proposed water distribution main extension to the Division of Water, Natural Resources and Environmental Protection Cabinet, Applicant shall obtain the Water District's approval of such plans and specifications, with such approval to be evidenced by the seal or stamp of the Water District and signature of duly authorized official affixed to the face of the plans and specifications.

5. Applicant shall reimburse the Water District for all expenses that the Water District incurs in its review of Applicant's proposed plans and specifications, inspection of constructed facilities, and any other reasonable actions necessary to facilitate the construction of the proposed water distribution mains. The Applicant shall deposit with the Water District at the time of executing an "Agreement For Water Main Extension to Serve A Real Estate Development," an amount equal to the Water District's estimate of these costs.

6. Applicant shall permit Water District employees, agents, or representatives reasonable access to the proposed real estate development upon reasonable notice and at reasonable hours.

7. Applicant shall obtain all necessary approvals from county planning and zoning commissions.

8. Applicant shall be responsible for the cost of the proposed water lines and appurtenant facilities, all costs arising out of the inspection and testing of water lines.

9. Applicant shall advise the Water District or its designated representative of the date and time for the commencement of construction and installation of all water mains within the proposed real estate development.

10. Applicant shall notify the Water District or its designated representative at least 24 hours in advance of any action to cover any portion of the proposed water mains. Applicant shall not cover with soil or other material any portion of the proposed water main extension until the Water District or its designated representative has inspected the water main.

11. Applicant shall notify the Water District or its designated representative at least 24 hours in advance of any action to cover or to test water mains. Applicant shall not test the proposed water main extension for leakage or contamination without the Water District's prior knowledge and agreement

12. Applicant shall grant to the Water District an easement or easements sufficient to install, repair, replace, or construct any facilities necessary to distribute and meter water to the existing or proposed real estate development and to each parcel of property located within the development. The Applicant's grant of easement to the Water District may be made and/or shown upon the recorded plat of the development.

13. Applicant shall, upon completion of construction of the proposed water distribution mains, notify the Water District in writing of the completion.

14. Within 60 days of completion of construction of the proposed water distribution mains and appurtenant facilities, the Applicant shall furnish to the Water District a copy of the as-built plans for the mains and appurtenant facilities, which as-built plans will contain a "Certification" by the Applicant's professional engineer that all construction has been performed pursuant to the Preliminary Plans as approved by the Division of Water and that all materials provided are of standard and acceptable quality, and that all work has been performed in a workmanlike fashion.

15. Within 45 days of receipt of the as-built plans with an appropriate "Certification" by the Applicant's professional engineer, the Water District will issue its preliminary acceptance or preliminary rejection of Applicant's as-built plans. When the Water District has preliminarily rejected the Applicant's as-built plans, it shall notify the Applicant in writing of its reasons for the rejection, state the actions necessary to cure all deficiencies that cause the rejection, and state the time period in which the Applicant has to take those actions.

16. Upon completion of proposed water distribution mains and the Water District's preliminary acceptance of the water distribution mains, Applicant shall grant to the Water District the right and authority to provide water service through the water distribution main. Applicant shall retain all ownership rights in the water distribution mains and appurtenant facilities, and all easements for property on which the water distribution mains and appurtenant facilities are situated, and shall be responsible for the operation and performance of such water distribution mains and appurtenant facilities, and for any expenses or costs related to their maintenance or repair for a period of 12 months from the date of the preliminary acceptance.

17. Within 60 days of the Water District's preliminary acceptance of the water distribution mains and appurtenant facilities, the Applicant shall provide to the Water District a written statement of the mains' total cost, itemizing in detail the components of the total cost.

B. If the Applicant contracts with the Water District for the design of the proposed water distribution main:

1. At the time of submitting its application, Applicant shall execute an "Agreement for Water Main Extension to Serve a Real Estate Development" similar in form and content to that shown in Appendix B.

2. Applicant shall provide the Water District or its designated representative with all preliminary plans and specifications of the proposed real estate development and proposed water main extension and any other documents as reasonably necessary to review Applicant's request for service.

3. At the time of executing an "Agreement for Water Main Extension to Serve a Real Estate Development" with the Water District, Applicant shall deposit with the Water District an amount equal to the estimated cost of design. During the course of the construction, the Water District may draw upon the deposited amount to pay such costs. If the Water District incurs any costs of design in excess of the deposited amount, Applicant shall pay such charges within 30 days of presentation of a Statement of Costs by the Water District. Applicant shall pay the total cost of design of the proposed water lines and appurtenant facilities. "Cost of design" includes, but is not limited to, all costs associated with the engineering and design of the proposed water distribution mains, fees for water permits, inspections and licenses. "Cost of design" shall not include any costs associated with obtaining any permits or approvals as may be required by local planning and zoning ordinances or regulations. "Cost of design" shall not include any expenses associated with obtaining or recording easements.

4. Applicant shall be responsible for the cost of the proposed water distribution mains and appurtenant facilities and all costs arising out of the inspection and testing of those mains.

5. Water District shall advise Applicant that all plans and specifications shall be made to ensure the quality and reliability of water service or the Water District's operational efficiency and integrity, and that such plans and specifications be consistent with accepted engineering standards.

6. Applicant shall permit Water District employees, agents, or representatives reasonable access to the proposed real estate development upon reasonable notice and at reasonable hours.

7. Applicant shall obtain all necessary approvals from county planning and zoning commissions.

2. Water District or its designated representative shall promptly inspect the proposed water main extension after receiving proper notice from the Applicant of its intent to cover the main with soil or other material.

3. Water District or its designated representative shall promptly advise Applicant of its decision on any testing of the proposed water distribution mains and appurtenant facilities.

4. Water District agrees to make preliminary acceptance of the dedication and donation of completed water distribution mains and appurtenant facilities from the Applicant upon certification of a professional engineer, licensed in the Commonwealth of Kentucky, that the water distribution lines are constructed in accordance with its plans and specifications as approved by the Natural Resources and Environmental Protection Cabinet and the Water District, and with accepted engineering practices.

5. The Water District shall, at its discretion, exercise reasonable efforts to the extent permitted by law to assist the Applicant in determining the route of the proposed water distribution main.

6. Within 60 days of its receipt of Applicant's written statement of the water distribution mains' total cost, the Water District shall advise Applicant of its acceptance of the stated cost or request additional information to support Applicant's statement of total cost. If Water District does not accept Applicant's statement of cost, it shall advise the Applicant of its reasons for rejecting the Applicant's statement and shall state its estimate of the total cost of the water distribution mains.

7. Upon its preliminary acceptance of the water distribution main, the Water District shall begin providing water service to any person applying for service through these mains.

8. Water District shall make its final acceptance of the water distribution mains and appurtenant facilities and shall assume ownership and all responsibility for its operation and maintenance after one year of operation without a significant leak or maintenance problem.

B. In those instances where the Applicant contracts with the Water District for the design of the proposed water distribution main:

1. Water District shall retain the services of a professional engineer licensed by the Commonwealth of Kentucky to prepare and/or examine all plans and specifications for the proposed water distribution main extension. Water District shall advise Applicant that all plans and specifications shall be made to ensure the quality and reliability of water service or the

2.
