

The vote was as follows: Council Members Bland, Dennison, House, Reed and Witten voting aye.

Motion by Witten, seconded by Reed that the Mayor be authorized to execute the following agreement with the Northeast Woodford Water District:

AGREEMENT

THIS AGREEMENT, made and entered into this the 7th day of July, 1982, by and between the NORTHEAST WOODFORD WATER DISTRICT, hereinafter referred to as the Water District, and the CITY OF VERSAILLES, a municipal corporation, hereinafter referred to as the City;

WITNESSETH:

WHEREAS, THE Water District purchases water from the City of Versailles; and

WHEREAS, a dispute has arisen between the Water Districts and the City over a rate increase and the sales price of water enacted in July of 1978, and all billings subsequent to the aforesaid rate increase; and

WHEREAS, the City contends that the Water District owes the sum of Fifteen Thousand Nine Hundred Forty-two and 16/100 (\$15,942.16) Dollars for water purchased at various times since the aforesaid rate increase; and

**RATES AND TARIFFS**

WHEREAS, the City has enacted and adopted a new water rate increase, effective as to all customers and effective as to the Water District as of April 4, 1982; and

WHEREAS, the Parties mutually agree that it is in the best interest of all concerned to resolve the instant controversy.

July 6, 1982

NOW THEREFORE, the Parties hereto agree as follows:

1. The Water District agrees to pay to the City the sum of Five Thousand (\$5,000.00) Dollars. The Five Thousand (\$5,000.00) Dollars paid by the Water District is to be in full and complete satisfaction of the Water District's debt in the alleged amount of Fifteen Thousand Nine Hundred Forty-Two and 16/100 (\$15,942.16) Dollars as hereinabove stated.

2. The Water District does hereby consent and agree to be bound by the terms, provisions and rates incorporated in the City's water rate which became effective as to the Water District as of April 4, 1982, as those rates, terms and provisions apply to the Water District. The District agrees to pay any outstanding bills resulting from the rate increase which is now due and owing the City. A copy of said current bill for water consumed by the District since the April 4, 1982, rate increase is hereby attached and made a part of the contract as if the same was fully set out herein.

3. The City does hereby agree that Section 17.125 of the Versailles Code, Changes to Water District, shall not be altered or amended through November 30, 1982.


