All other rates and charges not specifically mentioned herein shall remain the same as those in effect under the authority of The Commission prior to the date of this Order.

Rates:

First 2,000 Gallons used per month	\$6.00

All over 15,000 Gals. " " " " " "	1.00

Minimum Bill:

The minimum monthly charge shall be \$6.00 for which the customer is entitled to 2,000 gallons or less of water may be used.
