- Service Reconnection Charge. A charge of \$50.00 shall be made for all service reconnections made regular working hours, except that there shall be no connection charges made for service on the original installation of facilities. If service is reconnected other than during regular working hours, the charge shall be \$75.00. After hours reconnections are discouraged.
- 2. <u>Meter Reading Recheck Charge</u>. A charge of \$50.00 shall be made for a trip to recheck a meter reading when the customer requests the meter to be rechecked for a correct reading and the meter was not misread.
- 3. <u>Meter Test</u>. Upon request and payment of \$75.00, customer may have his meter tested provided request by the customer is not more frequent than once each twelve months. If such test shows the meter to be more than two percent fast, a refund of the \$75.00 charge shall be made and the bill adjusted accordingly. If the periodic testing requirement of 807 KAR 5:066 (17) has not been met for the meter tested, <u>no</u> charge will be made for the test regardless of the results of the test.
- 4. <u>PSC Meter Test Complaint</u>. Any customer of the District may request a meter test by written application to the Kentucky Public Service Commission and charges for this test will be as shown in 807 KAR 5:006, Section 20, © and will be collected by the Public Service Commission.
- 5. <u>Inspection of Service Line</u>. In the installation of a service line, the customer shall leave the trench open and pipe uncovered until it is inspected by the District and shown to be free from any tee, branch connection, irregularity, or defect. A fee of \$25.00 shall be charged for this inspection.
- 6. <u>Returned Check Charge</u>. A \$30.00 charge will be levied and paid by the customer to the District on each check of the customer "returned" for whatever reason.
- 7. <u>Contribution in Aid of Construction</u> Tap-on Fees and Connections. The established tap on or or connection fee is based on the size of the installed metering equipment and is as follows:
