Disagreements have arisen between West Shelby and the Johnsons and Wagner over extension of the water main referred to in numerical paragraph seven of the Water Service Agreement and the parties wish to resolve such disagreement with this document.

NOW THEREFORE, the parties agree as follows:

- 1. West Shelby shall extend the six inch main to the western property line of tract seven of Copper Coin Farm owned by Wagner forthwith and, in fact, West Shelby is in the process of constructing such extension at this time.
- 2. Wagner shall pay the lesser of one-fifth of the cost of that extension as contracted for by West Shelby or Three Thousand Dollars (\$3,000.00).
- 3. West Shelby shall insure that Wagner's property and the Johnsons' property, to the extent that either is affected by the water line extension, are restored to their condition prior to the initiation of any work or the undertaking of any efforts on or adjacent to said properties by or for West Shelby.
 - 4. West Shelby acknowledges that Wagner and the Johnsons have complied with

all of their obligations under the Water Service Agreement and are appropriately metered and in compliance with all West Shelby rules and regulations.
