WHEREAS, due to unforeseen circumstances minor changes in the location of the water meter pit has been made, and

WHEREAS, the parties wish to amend their original Agreement for the purpose of providing for the installation and maintenance of additional lines.

NOW, THEREFORE, in consideration of the foregoing promises and undertakings hereinafter specified, the parties agree as follows:

1. That all of the terms and conditions of the parties' original Agreement dated March 3, 1992, are hereby incorporated herein by reference to the extent that same are not inconsistent herewith. The parties agree to comply with and perform all the terms and conditions therein.

2. That do to the relocation of the water meter pit at the site of "tap in" with the City water system, the District shall relocate said water meter pit approximately 60 feet from the point of "tap in" between the District's water system and the City's water system. It is agreed by the parties hereto that the District

shall be solely responsible for the installation and maintenance of said 60 foot line extension.
