B. Meter Rates for Water Usage in Addition to Minimum Charge

Subject to the minimum monthly water rates specified above, the following metered charges shall be made for each 1,000 gallons of water consumption per month to customers of all size connections:

Number of Gallons of Water per Month	Monthly Charge per 1,000 Gallons Per Month
First 2,000 gallons	\$ 8.78 - Minimum Bill
Next 2,000 gallons	3.27 - per 1,000 gallons
Next 2,000 gallons	2.71 - per 1,000 gallons
Next 4,000 gallons	2.16 - per 1,000 gallons
All over 10,000 gallons	1.89 - per 1,000 gallons
