RULES AND REGULATIONS

The following rules and regulations are subject to change by the Commission at any time.

These rules and regulations are intended to supplement the bond resolution, the rate resolution, and the By-Laws:

1. Meters will be read monthly between the 15th and 20th of each month.

2. Bills will be dated and mailed on the first of each month. Said bills will state that they are to be paid within ten days. However, provisions contained in the rate regulations as to penalties and cut-offs will apply.

3. All meters will be located on district mains and in the absence of special permission on the property to be served. Reference is made to a more detailed explanation contained in the By-Laws.

4. Complaints may be made to the operator of the system and may be appealed to the district commission within 10 days.

5. The principal place of business of the district will be the County of Muhlenberg, Bremen, Kentucky.

6. Water bills shall be paid at Bremen, Kentucky.
