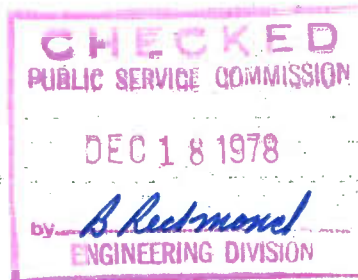

Over	50,000 Gallons	\$1.10 per 1,000 Gallons
