RULES AND REGULATIONS

CUSTOMER DEPOSITS

North Mercer Water District's rules and regulations effective September 23, 1985, related to deposits is hereby void.

Pursuant to 807 KAR 5:006 Section 7(7), North Mercer Water District shall require each customer to deposit \$60.00. Each of said deposits will remain with the District during the time service is provided to each customer.

North Mercer Water District shall pay each customer making deposits the equivalent rate of interest on such deposits, as the District has received for the previous year. Each customer's account will be credited the interest accrued annually in January for the portion of the preceding year that the monies were on deposit.

Any reference to KRS 74.050 and KRS 273.392, relating to customer deposits and interest payment are hereby deleted.
