RULES AND REGULATIONS

SCHEDULE OF SPECIAL SERVICE CHARGES

- 1. <u>Service Connection Charge:</u> A charge of \$15.00 shall be made for all service reconnections made during regular working hours, except that there be no connection charge made for service on the original installation of facilities. If service is reconnected other than during regular working hours, the charge shall be \$35.00.
- 2. <u>Delinquent Service Charge</u>: A charge of \$15.00 shall be made for a trip to disconnect a delinquent account. A reconnection charge of \$15.00 shall be made if reconnected during regular working hours. If reconnected or disconnected after regular working hours, the charge shall be \$35.00.
- 3. Meter Investigation Charge: When an investigation of facilities on customers' premises reveals meter seal broken, damaged meters, or unauthorized use of water, a meter investigation fee of \$15.00 shall be charged. The actual cost of repairing damage to meter service, if any, shall also be charged and the customer's bill shall be paid for the amount of water service rendered.
- 4. Meter Test Request: Upon request and payment of \$15.00, a customer may have his meter tested provided request by the customer is not more than once each twelve months: If such test shows the meter to be more than 2% fast, a refund of the \$15.00 charge will be made and the bill adjusted accordingly.
- 5. <u>Late Payment Penalty Charge:</u> A charge of 10% shall be added on each customer's unpaid bill after the 20th of each month.
- 6. Return Check: A charge of \$25.00 shall be charged for any returned check received by the District.
