restore service.

3. (Billing Procedure) To furnish the Purchaser at the above address not later than the 26<sup>th</sup> day of each month, with an itemized statement of the amount of water furnished the Purchaser during the preceding month.

## B. The Purchaser Agrees:

1. (Rates and Payment Date) To pay the Seller, not later than the 10<sup>th</sup> day of each month (subsequent to the receipt of the bill), for water delivered in accordance with the following schedule of rates:

- a. \$2.00 (Two dollars) per 1,000 gallons of water for all water provided to Purchaser from the Seller's own water treatment plant located in Frogtown.
- b. \$2.77 (Two dollars and seventy-seven cents) per 1,000 gallons of water for all water provided to Purchaser that is purchased by Seller from Southern Water & Sewer District. It shall be the responsibility of the Seller to maintain complete and accurate records related to the dates and times that it is necessary for the Seller to deliver water to Purchaser from the Jones Fork tank (ic: water purchased from Southern Water) in lieu of water produced at its own water treatment plant.

2. (Metering Equipment) To furnish, install, operate, and maintain at its own expense at point of delivery, the necessary metering equipment, including a meter house or pit, and required devices of standard type for properly measuring the quantity of water delivered to the Purchaser and to calibrate such metering equipment whenever requested by the Seller but not more frequently than once every twelve (12) months: A meter registering not more than two percent (2%) above or below the test result shall be deemed to be accurate.

The previous readings of any meter disclosed by test to be inaccurate shall be corrected for the 6 (six) months previous to such test in accordance

with the percentage of inaccuracy found by such tests. If any meter fails to register for any period, the amount of water furnished during such period

shall be deemed to be the amount of water delivered in the corresponding period immediately prior to the failure, unless Seller and Purchaser shall

agree upon a different amount. The metering equipment shall be read on or about the 22<sup>20</sup> day of each month. An appropriate official of the

Purchaser at all reasonable times shall have access to the meter for the purpose of verifying its readings.

## C. It is further mutually agreed between the Seller and the Purchaser as follows:

I. (Term of Contract) That this contract shall extend for a term of <u>10 (ten)</u> years from the date of the initial delivery of any water as shown by the first bill submitted by the Seller to the Purchaser and, thereafter may be renewed or extended for such term, or terms, as may be agreed upon by the Seller and Purchaser.

2. (Deliver of Water) That 20 (twenty) days prior to the estimated date of completion of the Purchaser's water supply distribution system, the Purchaser will notify the Seller in writing the date for the initial delivery of water.

3. (Water for Testing) When requested by the Purchaser, the Seller will make available to the contractor at the point of delivery, or other point reasonably close thereto, water sufficient for testing, flushing, and trench filling the system of the Purchaser during construction, irrespective of whether the metering equipment has been installed at that time, at a charge of \$2.00 per 1,000 gallons, which will be paid by the contractor or, on his failure to pay, by the Purchaser.

4. (Failure to Deliver) That the Seller will, at all times, operate and oraintain its system in an efficient manner and will take such action as may be necessary to furnish the Purchaser with quantities of water required by the Purchaser. Temporary or partial failures to deliver water shall be remedied with all possible dispatch. In the even of an extended shortage of water, or the supply of water available to the Seller is otherwise diminished over an extended period of time, the supply of water to Purchaser's consumers shall be reduced or diminished in the same ratio or proportion as the supply to Seller's consumers is reduced or diminished.

5. (Modification of Contract) That the provisions of this contract pertaining to the schedule of rates to be paid by the Purchaser for water delivered are subject to modification at the end of every 1 (one) year period. Any increase or decrease in rates shall be based on a demonstrable increase or decrease in the costs of performance hereunder, but such costs shall not include increased capitalization of the Seller's system. Other provisions of this contract may be modified or altered by mutual agreement

6.
