6.02.03 ELEVATED SERVICE AREA SURCHARGE

All customers shall pay a surcharge of \$.25 per thousand gallons if water must be delivered at a higher elevation than the general pressure plane served by the Crescent Hill/Cardinal Hill System, excluding customers in the Kentucky Turnpike #2, Goshen Utilities, and Shepherdsville services under one (1) inch areas.

6.03 WHOLESALE CUSTOMERS

Wholesale customers which purchase water for resale wherever situated shall be charged: \$ 1.38 per thousand gallons for all water purchased, the elevated service area surcharge specified in Rule 6.02.3 if applicable and the service charge specified in Rule 6.02.1.
