RULES AND REGULATIONS

1. These rules and regulations are in addition to the rules of the Kentucky Public Service Commission.
2. Any resident or business of Barkley Lake Wster District is eligible for water service from the District providing a water main is within 50 feet of his property line.
3. Water service will be terminated within 24 hours after receiving request from customer requesting discontinuance.
4. All applications for service shall be accompanied by a deposit of \$75.00 to assure payment of the bill. Interest is credited on an annual basis. The deposit is refunded when the applicant no longer needs service.
5. All applications for new service connections shall be accompanied by a tap-on fee in the amount of \$450.00. All meters larger that 1" – Actual cost of material and installation.

RULES AND REGULATIONS

6. The customer shall be responsible for all plumbing installed on his property beginning at the outlet side of the meter. Said installation shall be in accordance with the Kentucky State Plumbing Law, Regulations and Code per KRS 318 as enforced by the Division of Plumbing of the Department of Housing, Building and Construction. Cross connections On customer's premises between the District's water system and any Non-public water system are prohibited.
7. No customer shall resell water except under the terms of a special contract executed with Barkley Lake Water District.
8. All services shall be metered.
9. The district shall not furnish free water to any person for any reason.
10. A fee of \$20.00 shall be charged for re-establishing discontinued service. A fee of \$50.00 shall be charged to reestablish service for a seasonal turn-off. A fee of \$20.00 shall be charged for a check returned from the bank for insufficient funds.

RULES AND REGULATIONS

- 11. No connections to the water pipes of the system shall be made except by Or under the supervision of a duly authorized official, agent, or employee of the District.
- 12. If the water service of any customer is discontinued for the non-payment of bills, the District shall require payment of \$20.00 reconnection fee and payment of all delinquent water bills, including penalties and interest, in full before reconnection is made.
- 13. All meters shall be billed every month.
- 14. Bills shall be rendered on or about the 1st day of the month and shall be be due and payable upon receipt. If the bill remains unpaid at the close of business on the 15th day of the month, the account shall be deemed delinquent and a 10% late payment charge shall be added in accordance with 807 KAR 5:006 Section 8(3)(h). A penalty will not be assessed on unpaid penalty charges.
- 15. A five (5) day written notice of disconnection of service will be mailed on the 20th of the month to all accounts deemed delinquent. At no time will service be terminated before twenty (20) days have passed following the mailing date of the original unpaid bill. Any account that remains past due after 90 days shall be turned over to the Credit Bureau for collections.

RULES AND REGULATIONS

16. Customers usage is monitored monthly when meters are read. When it is found that usage has increased by 100%, door hangers are left for active customers and letters are mailed also. Phone calls are made when necessary.
17. In the event a customer's consumption increases three (3) times their normal bill due to a leak, their bill will be adjusted $\frac{1}{4}$ off. If their consumption increases ten (10) their normal bill due to a leak, their bill will be adjusted $\frac{1}{2}$ off. It shall be the customer's responsibility to repair any leak immediately upon discovery and the bill will be adjusted only after the leak is repaired. In no case will the customer pay less than the actual cost of water per 1,000 gallons.
18. If a meter tested upon complaint of a customer is found to register not more than two percent (2%) fast, the cost of such test (\$25.00) shall be borne by the customer. However, if the meter shall be found to register more than two percent (2%) fast, the cost of such test shall be borne by the utility.
19. The contents of the billing form shall include the following: Account number, address of services, readings of meter, usage of water, amount of tax, due date, net amount of bill, gross amount if not paid by due date, name and address of customer.

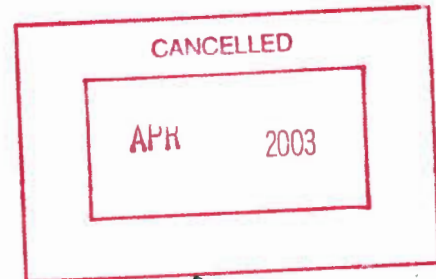
CLASSIFICATION OF SERVICE
