RULES AND REGULATIONS

The following rules and regulations are subject to change by the Water District Commissioners at anytime subject to approval by the Public Service Commission:

1. A customer who desires a water service will enter into a written agreement with the Water District, specifying which of two classifications of water is desired. Service connections will be made in accordance with the provisions of 807 KAR 5:066E Section 13.
2. The Water District may terminate service to any customer failing to pay a water bill within 20 days of the mailing date of the original bill, after having been given 5 days written notice of such intentions.
3. When the water supply to the customer has been discontinued for non-payment of delinquent bills, a charge of \$25.00 will be required of the customer for reconnection of water service. This charge includes the cost of disconnecting the service. The reconnection will not be made until all delinquent bills and reconnection is paid. Discontinuance of service for nonpayment of bills shall be made in accordance with the provisions of 807 KAR 5:006E Section 11.
4. Whenever a meter in service is found upon written request or complaint to be in excess of two percent fast or slow the method for calculating the bill adjustment shall be that percentage of error as determined by the test, in accordance with 807 KAR 25:010 rules and procedures.
5. Extension of service shall be made pursuant to the provisions of 807 KAR 5:066E, Section 12.
6. Meters will be read every other month between the 15th and 20th.
7. Bills will be dated the date the meters are read and mailed on the first of each month. Said bills will state a 10% penalty will be applied if not paid by the 20th of the month.
8. Complaints may be made to the operator of the system and may be appealed to the District Commissioner.
9. Water bills may be paid at the City Clerk's Office with whom the Water District shares an office at Brooksville, Kentucky.
10. The Water District Commissioners will meet on the second Monday of each month at the office of the Water District at 7:30 P.M.

Bracken County Water District No. 1 shall issue to every customer from whom a deposit is collected a receipt of deposit. A "Receipt of Deposit" is enclosed as a tariff sheet.

Customer service may be refused or discontinued pursuant to 807 KAR 5:006 Section 14 if payment of requested deposits is not made.

Interest shall accrue on all deposits at the rate prescribed by law, beginning on the date of deposit. Interest accrued shall be refunded to the customer or credited to the customer's bill on an annual basis, except that Bracken County Water District No. 1 shall not be required to refund or credit interest on deposits if the customer's bill is delinquent on the anniversary of the deposit date. All interest that has accrued shall be refunded or credited to the customer's bill on the first anniversary of the deposit date. If interest is paid or credited to the customer's bill prior to twelve (12) months from the date of deposit, the payment or credit shall be on a prorated basis. Upon termination of service, the deposit, any principal amounts, and interest earned and owing shall be credited to the final bill with any remainder refunded to the customer.

Bracken County Water District No. 1 shall issue adjustments to a customer's bill only in order to fulfill the Public Service Commission regulations. For example, 807 KAR 5:006 Section 10 specifies the conditions under which a customer's bill may be adjusted as a result of a meter test.

However, in an effort to be fair to all customers, as of the effective date of this tariff, Bracken County Water District No. 1 will no longer issue credits for leaks within the water system on the customer's side of the meter.

Adjustments will be issued for water used for flushing brown water if the customer's bill for the period in which the flushing occurred was greater than the customer's average bill on a case by case basis where the presence of brown water is documented and the amount of water flushed is within reason.

A Service Investigation Charge of forty dollars (\$40) will be assessed when a Bracken County Water District No. 1 representative makes a trip to the premises of a customer for a service investigation that is not the result of the failure of the Water District's facilities. These service investigations include helping customers find leaks on the customer's side of the meter, trips caused by the customer supplying an incorrect address, broken meter seals in a meter to a customer, other damage to the meter service, unauthorized use of water, etc. Any maintenance and/or repair of facilities beyond the Water District's point of delivery is the responsibility of the customer. The point of delivery is the point where the meter or appurtenance for the customer is located. The customer is responsible for the actual cost of repairing any damage to the meter service.

No person shall maliciously, willfully, or negligently break, damage, destroy, uncover, deface, or tamper with any structure, appurtenance, or equipment which is a part of the District's water system. Any person violating this provision shall be subject to discontinuation of water service and shall pay the cost of repairing or replacing the affected components of the water system as may be determined by a court of law having jurisdiction.

All service lines beyond the metering point should be installed of material consisting of copper or PVC pipe with a rating of not less than 160 psi. The size of the service line beyond the point of delivery should not be less than 3/4"; however, a larger size may be needed to provide adequate service. If the customer's point of use is at a higher elevation than the point of delivery, the customer should consult with a reputable engineering firm to size the service line from the point of delivery. Piping on the premises of a customer must be so installed that connections are conveniently located with respect to the District lines and mains. The customer shall provide a place for metering which is unobstructed and accessible at all times.

Should a prospective customer request service at a point of delivery which now, or in the future, does not provide a delivery pressure of 30 psi or does not meet his personal requirements, he may make provision for an individual pressure booster system. The manner of connection, location, cross-connection, protection and type is subject to approval by the District. The District reserves the right to require discontinuance and disconnection should the private booster system have a detrimental effect on the District's system.

In the installation of a service line, the customer shall leave the trench open and the pipe uncovered until it is inspected by the District and is shown to be free from any tee, branch connection, irregularity or other defects.

Discontinuance of Service by District

Water service may be discontinued by the District for violation of any rule, regulation, or condition, and especially for any of the following reasons:

- A. Misrepresentation in the application or contract as to the property or fixtures to be supplied or additional use to be made of the water purchased from the District;
- B. Failure to report to the District additions to the property or fixtures to be supplied or additional use to be made of the water;
- C. Resale of water or giving away of water;
- D. Waste or misuse of water due to improper or imperfect service pipes and/or failure to keep such pipes or connections in a suitable state of repair;
- E. Tampering with the meter, meter seal, service, or valves, or permitting tampering by others;
- F. Connection, cross connection, or permitting the same, of any separate water supply to premises which receive water from the District;
- G. Non-payment of bills;
- H. Connecting more than one residence or mobile home to a meter;
