DEPOSIT OF \$45.00 REQUIRED OF TENANTS OR ANY CUSTOMERS, WHICH IS REFUNDABLE. (THE DEPOSIT IS TWICE THE AVERAGE MONTHLY BILL <\$22.55> UPON TERMINATION OF SERVICE.)
