NEXT	1,000 GALLONS	4.40 PER 1,000 GALLONS
NEXT	3,000 GALLONS	4.30 PER 1,000 GALLONS
NEXT	5,000 GALLONS	4.20 PER 1,000 GALLONS
NEXT	10,000 GALLONS	3.30 PER 1,000 GALLONS
NEXT	20,000 GALLONS	2.50 PER 1,000 GALLONS
ALL OVER	40,000 GALLONS	2.35 PER 1,000 GALLONS

DEPOSIT OF \$45.00 REQUIRED OF TENANTS OR ANY CUSTOMERS WHICH IS REFUNDABLE. DEPOSIT AND INTEREST MAY BE APPLIED BY THE DISTRICT AGAINST ANY UNPAID BILLS OF THE CUSTOMER, AND IF ANY BALANCE REMAINS AFTER SUCH APPLICATION IS MADE SAID BALANCE SHALL BE REFUNDED TO THE CUSTOMER.
