All customers may pay their bills by credit/debit card. This method of payment may be made in person at the office or by phone. If on the bill due date, an attempt to pay by credit/debit card is made and the card is declined for any reason, payment is still due in full on that date and will be considered late after that date. All late charges and penalties will be applied. If a customer is paying on our disconnect day and the card is declined, the same rules as above apply, in addition to service being disconnected.

When a customer makes a payment by credit card, the utility will assess a fee equal to the charges to the utility by the credit/debit card processing company to process the transaction. This fee is generally calculated using a formula applied to the balance of the amount charged to the credit/debit account but may be a flat fee per transaction. Prior to processing the transaction, the customer will be informed of the fee amount and upon request by the customer, the formula employed to arrive at this fee amount.

**FIRE DEPARTMENTS:**

Any city, county, urban-county, charter county, fire protection district, or volunteer fire protection district ("User") may withdraw water from the utility's water distribution system for the purpose of fighting fires or training firefighters at no charge on the condition that it maintains estimates of the amount of water used for fire protection and training during the calendar month and reports the amount of this water usage to the utility no later than the 15<sup>th</sup> day of the following calendar month.

Any city, county, urban-county, charter county, fire protection district, or volunteer fire protection district that withdraws water from the utility's water distribution system for fire protection or training purposes and fails to submit the required report on water usage in a timely manner shall be assessed the cost of this water.

A non-reporting user's usage shall be presumed to 0.3 percent of the utility's total water sales for the calendar month. A non-reporting user may present evidence of its actual usage to rebut the presumed usage. The utility shall consider this evidence and may adjust the presumed usage amount accordingly.

The non-reporting user shall be billed for this usage at the lowest usage block rate regardless of customer classification that the utility charges.

A non-reporting user shall also be assessed a penalty of \$ 25.00 for each failure to submit a report in a timely manner.

**DEPOSITS**

All customers will pay equal deposits as set forth in this tariff. Interest will accrue on all deposits at the rate prescribed by law beginning on the date of the deposit. Interest accrued will be refunded to the customer or credited to the customer's bill on an annual basis. If interest is paid or credited to the customer's bill prior to twelve (12) months from the date of deposit or the last interest payment date, the payment or credit shall be on a prorated basis.

Deposits will be returned after one (1) year if the customer has established a satisfactory payment record for that period. The district considers a customer to have a satisfactory payment record if they have had no more than three late payments within a twelve (12) month period. If a deposit has been returned and the customer fails to maintain a satisfactory payment record, another deposit may be required. Upon termination of service, any deposit and interest owed to the customer will be credited to the final bill with any remainder refunded to the customer.

**LEAK ADJUSTMENTS**

RULES AND REGULATIONS

The following rules and regulations are made and approved by the Corinth Water District and no employee of the Corinth Water District has any power or authority to alter or change these rules and regulations.

1.) APPLICATION FOR CONNECTION: Connection to the mains of Corinth Water District, hereinafter referred to as "District" will be made on the written application on blanks provided by company, after applicant agrees to comply with the rates, rules, and regulations of company, and after the approval of the application by district indorsed thereon. The size of service lines, valves, meters, and other fittings, fixtures, or appliances necessary to render the service for which application is made shall be determined by district.

2.) APPLICATION FOR SERVICE: On application of the owner or any authorized agent or any tenant of the owner, water will be furnished through existing connections, or, on application of the owner, through new connections, after owner agrees to comply with the rates, rules, and regulations of district, and after the approval of the application by district indorsed thereon. The application shall state the name of the owner of the premises, the character and extent of the service desired, a description of the premises, including the name of the street and house number, if any, the number and kind of fixtures through which water will be supplied, and such other information as district may reasonably require.

3.) CHANGE IN OWNERSHIP, TENANCY, OR SERVICE: A new application must be made and approved by the district on any change in ownership of property, or in tenancy, or in the service, as described in the original application, and district may discontinue the water supply until such new application is made and approved.

4.) PAYMENTS: At the time of making application for connection or service, the applicant must make payment to district of the fees, deposits, or rates as the case may be, fixed by the Corinth Water District for the service requested.

5.) CONNECTIONS: District will furnish and maintain at its own cost all necessary fittings, pipes, and appliances, including all meters and meter boxes, necessary for delivery of water to the consumer's pipeline at a point just inside the curb line on the street and just outside the property line in alleys or other public places. All such fittings, pipes, appliances, meters, and meter boxes shall remain the property of district and shall at all times be accessible to district and under its control. The service line from the curb box or meter to the consumer's premises shall be laid and maintained by consumer at his own cost. The line shall be of ample size, of standard weight and quality, and all cutoffs, valves, fixtures, and appliances furnished by consumer shall be maintained in good order and condition.

6.) LEAKS: Any leak in any pipe or fixture on the premises of consumer shall be immediately repaired. Service may be discontinued until such repair is made.

7.) INSPECTION: All pipes, meters, or fixtures shall, at all reasonable hours, be subject by district or its duly authorized agents. *to inspection*

8.) DAMAGES: District shall in no event be responsible for maintaining any service line owned by the consumer, nor for damages done by water escaping therefrom, nor for defects in lines or fixtures on the property of consumer. The consumer shall at all times comply with all regulations of the ~~Water Utility~~ <sup>Public Service</sup> Regulatory Commission of KY. of the state of KY, of the municipality, and of district, relating to the service lines, and shall make all changes in his lines required on account of changes in grade or otherwise.

(a) The owner of a single building used as a dwelling or apartment house, and occupied by one or more families, may connect such building or apartment house, if not already connected, with the mains of district and be served by a single service line for which <sup>a</sup>one minimum charge shall be paid, <sup>by each individual apartment</sup> in which case the application for service shall be made by the owner or his duly authorized agent and the bills for water shall be paid by the owner;

(b) Each separate place of business ~~having three (3) or more~~ <sup>more</sup> ~~units~~, if supplied with water connection or if using water from district's mains, shall be considered a separate building, and shall pay a separate minimum charge;

(c) Where a building is occupied on the ground floor for business purposes and upper floors for office or for dwelling purposes, if the application is signed by the owner <sup>then</sup> and the water bills for all floors shall be considered as one service, and <sup>a separate</sup> ~~a~~ minimum charge shall be paid ~~for such upper floors, provided a separate~~ ~~charge is included;~~

(d) Where two or more families or places of business, or offices in a single building, are supplied with water to a single service line, and the owner of the building or his duly authorized agent fails or refuses to sign an application for service, or fails to pay the bills for water when due, or fails to abide by all the rules and regulations of district, service may be discontinued; but no such action involving the shutting off of the water supply of an innocent consumer shall be taken without first affording the tenant of the premises, . . .

opportunity to make a new application for supply of water through a separate service line or meter;

(e) Where two or more buildings or two or more families or establishments in a single building are supplied by a single service line with the approval of district, and where the owners are occupants of such buildings or such families or establishments desire to contact separately for water furnished, the owner shall first arrange the several house connections, or the plumbing, in such a way that a separate meter and stop and waste cock, with seal approved by district, and be placed on the supply line of each of such consumers. The district shall thereupon install separate connections for each consumer making application thereof, and in such cases, a separate minimum charge shall be assessed against each consumer.

~~11~~.) TRANSIENT CONSUMERS: In the case of transient consumers, or consumers taking water for less than three(3) months, district may make a minimum charge of not less than the cost of making connection with its mains and installing, reading, and removing meter, and charge for water consumer at regular meter rates. District may require a deposit to be made, in advance, by such temporary or transient consumer to cover the cost of making the connection.

12.) STOP AND WASTE VALVE: A stop and waste cock or cut off valve must be placed in the pipeline on the premises of the consumer, to be used in case of break or other necessity, whereby pipes to be repaired can be cut off without the necessity of using the street cutoff.

13.) METERS: All meters shall be furnished by district and shall remain the property of district and be accessible to and subject to control. Meters shall be conveniently located at a point approved by district, so as to control the entire supply, and when located on premises of consumer a proper place and protection thereof shall be provided by consumer.

(b) Meters will be maintained by district, so far as ordinary wear and tear are concerned. However, when meters located inside a building or cellar is damaged by freezing or hot water or any other external cause, consumer shall pay the cost for such damage. Consumer shall notify district of any damage to or the malfunction of a meter as soon as the damage or malfunction comes to consumer's knowledge.

(c) When water is furnished by meter, the quantity recorded by the meter shall be conclusive on both consumer and district, except when the meter has been found to be registering inaccurately or has ceased to register. In the latter case, the quantity may be determined by the average registration of the meter when in order.

(d) In case of a disputed account involving the accuracy of a meter, such meter shall be tested on request of consumer in conformity with the provisions of the rules and regulations pertaining to the water service utilities of the Corinth Water District. If the meter so tested is found to have an error in registration of Two Per Cent (2%) or more, the bills will be increased or decreased accordingly.

14.) DISCONTINUANCE OF SERVICE: Service under any application, including public fire protection, and by any other minicipal use, may be discontinued for any of the following reasons:

(a) For misrepresentation, in application, as to property or fixtures to be supplied, or the use to be made of the water supply.

(b) For the use of water on any property for a purpose other than that described in the application. Use of running water to prevent freezing, or to cool containers or the contents thereof, is not legitimate use and is particularly prohibited.

(c) Under flat rate service, for adding to the property for fixtures or for changing the use to be made of the water supply, without notice to and the consent of district.

(d) For willful waste of water through improper or imperfect pipes, fixtures, meter, or otherwise.

(e) For failure to keep in good order and to protect the district connections, service lines, or fixtures.

(f) For neglecting to make ~~or~~ a DEPOSIT for nonpayment of any account for water supplied or water service or fire protection, or for any scheduled fee or charge as required by paragraph 4 of the rules and regulations.

(g) For molesting any service pipe, meter, curbstop cock, or any other appliance of district controlling or regulating the water supply.

(h) In case of vacancy of premises.

(i) For violation of any rules of district.

Water will be turned off any premises, on the written order of consumer without in any way affecting the existing application.

15.) MANNER OF CUTTING OFF WATER SUPPLY: No water fixture or appliance in connection therewith will be considered cut off until it is discontinued so that it cannot be used again, or is sealed in a manner satisfactory to district.

16.) PERSONS AUTHORIZED TO TURN OFF WATER: No plumber, owner, or other unauthorized person shall turn the water on or off at any stop, or disconnect or remove the meter without the consent of district.

17.) DISCONTINUANCE OF WATER SERVICE IN EVENT OF EMERGENCY:

As necessity may arise in case of break, emergency, or for any other unavoidable cause, district may temporarily cut off the water supply in order to make necessary repairs, connections, or the like. However, district will use all reasonable and practicable measures to notify consumer of such discontinuance of service. In such case, district shall not be liable for any damage or inconvenience suffered by consumer or for any claim against it at any time for interruption in service, lessening of the supply, inadequate pressure, a poor quality of water, or for causes reasonably beyond district's control.

18.) RESERVE FOR EMERGENCY: District may reserve a sufficient supply of water at all times in its reservoirs to provide for fires and other emergencies or may restrict or regulate the quantity of water used by consumers in case of scarcity or whenever the public welfare may require it. No street or lawn sprinkling shall be done at times of water shortage, and sprinkling shall be discontinued during the period whenever a fire alarm has rung.

19.) RENEWAL OF SERVICE: When service has been discontinued, the district will renew services on proper application, when conditions under which the service was discontinued are correct, and on the payment of all charges provided in the schedule of rates or tariffs of district. A consumer whose service has been discontinued at one residence or place of business may not have service renewed at another

residence or place of business until all demands of district for water furnished have been paid, and district's rules and regulations are complied with.

(a) Where application is made by a person who is not the owner of the premises to be supplied, district may require a deposit to be made, the amount of which is based on the character of the service desired, but the same shall not exceed one-quarters minimum water bill.

(b) Where water has been turned off for nonpayment of a bill, or for any other valid reason, it shall not be turned on again until consumer has paid the turn on charge as fixed in the schedule of rates. The same charge shall be made for turning off water at the request of consumer due to repairs on consumer's premises or to report a vacation or disuse.

19.) TERMS OF PAYMENT: All minimum charges for meter rates shall be due and payable monthly : on or before the 15th day of the month. All meter charges over and above minimum charges shall be payable monthly at the same time, for services rendered during the preceding three months.

20.) ABATEMENT AND REFUNDS: No abatement on meter bills will be made for leaks or for water wasted by damaged fixtures.

21.) AGREEMENTS OR REPRESENTATIONS BY AGENTS OF DISTRICT: No agent or employee of district shall have authority to bind district-

by any promise, agreement, or representation in violation of these rules and regulations.

22.) USE OF WATER FROM FIRE HYDRANT: No person except an employee of district duly authorized shall take water from any fire hydrant for any prupose except for fire purpose or for use of the fire department in case of fire, and water shall not be taken from a fire hydrant for sprinkling streets, flushing gutters or sewers, or for any other purpose except the extinguishment of fires, unless specifically permitted in writing by district for the particular time and occasion.

23.) FIRE HYDRANTS:  
fire hydrants contemplates the use of sufficient amount of water through such hydrants for the bona fide purpose of extinguishing fires, by or under the supervision of fire department employees or officials and does not authorize the use of the hydrants and the water that flows through them by so-called salvage companies or any other unauthorized person.

24.) FURNISHING OF WATER BY CONSUMER TO OTHERS: No consumer will be allowed to furnish water to another person, except in cases of emergency, and then only for a limited time, or until such emergency has passed.
