SOUTHEAST DAVIESS COUNTY WATER DISTRICT

RULES AND REGULATIONS

1. These rules and regulations are in addition to the rules of the Kentucky Public Service Commission.
2. Any resident of SOUTHEAST DAVIESS COUNTY WATER DISTRICT is eligible for water service from the District provided said resident does not require a special line to be laid in order to accommodate said resident.
3. Water service will be terminated within 24 hours after receiving a written request from the customer requesting discontinuance.
4. All applications for service, where meter is already existing on property, will be accompanied by a deposit of \$10.00, refundable at termination of service after all outstanding bills are paid.
5. The point of delivery of water is the point where the meter is located on the customer's premises. All water lines, plumbing and equipment beyond the meter shall be maintained by the customer.
6. All meters, service connections and other equipment shall be and remain the property of the District. Customers shall provide a space for, and exercise proper care to protect the property of the District on its premises, and in the event of loss or damage to the District's property arising from the neglect of customer to care for same, the cost of necessary repairs or replacements shall be paid by the customer.
7. Meters will be read and bills rendered monthly.
8. Ten days will be allowed for payment of bill. After due date (due date shown on billing card) 10 percent penalty will be added to the bill.
9. After due date and upon five days written notice, water service will be discontinued for non-payment of water service bill.
- * (a) After service is discontinued, the customer shall pay his delinquent account plus \$10.00 to reconnect service.
10. All bills are payable at any office of the Central Bank & Trust Co., Owensboro, Kentucky.
