RULES AND REGULATIONS

- A. Each consumer of water services who desires service shall file an application on forms provided by the District and pay the connection or service charges applicable for the service requested.
- B. The applicant shall furnish information as follows:
 - 1. Name of occupant;
 - 2. Mailing address of occupant;
 - 3. Location of real property being served;
 - 4. Name and mailing address of owner of real property being served;
 - 5. Type of service requested and number of units; and,
 - 6. Such other billing data as may be required on the forms supplied by the District
- C. All taps and connections to the mains of the District shall be made by and/or under the direction and supervision of District personnel.
- D. Discount:
No discount is allowed.

RULES AND REGULATIONS

E. Water service may be discontinued by the District subject to the notice requirement of 807KAR 5:006, Section II, and especially for any of the following reasons:

1. Misrepresentation in the application or contract as to the property or fixtures to be supplied or additional use to be made of water.
2. Tampering with meter, meter seal, service, or valves, or permitting such tampering by others.
3. Connection, cross-connection, or permitting the same, of any separated water supply to premises which receive water from the District.
4. Non-payment of bills.

RULES AND REGULATIONS

- F. Any customer desiring service discontinued or changed from one address to another shall give the utility three (3) days Notice in person or in writing at the business office of the District; otherwise, a customer shall remain liable for all water used and service rendered by the District until said notice is received by the District.
- G. Bills and notices relating to the conduct of the business of the District will be mailed to the customer at the address listed on the Application for Water Service unless a change of address has been filed in writing with the District; and the District shall not otherwise be responsible for delivery of any bill or notice nor will the customer be excused from the payment of any bill or any performance required in said notice.
- H. The rates and charges for water service as herein provided shall be billed to the consumer receiving service and in whose name the utility has the account, absent other arrangements agreed to in writing with the landlord-owner.

RULES AND REGULATIONS

- I. When the Commission has discovered evidence that by fraudulent or illegal means the customer receiving service has obtained unauthorized service, or has diverted the service for unauthorized service, or has obtained service without same being properly measured, the service may be discontinued without notice. The Commission shall not reinstate service until the customer has complied with all rules of the utilities and regulations of the Commission, and the District has been reimbursed for the estimated amount of the service rendered and the cost incurred by reason of the fraudulent use, including the cost of removal and installation of water meters.
- J. The Commission shall, upon written request of the owner of the real property, direct all bills to the owner of the real property served or to the occupant of the premises.
- K. Where a meter has ceased to register, or meter reading could not be obtained, the quantity of water consumed will be based upon an average of the prior six months' consumption and the conditions of water service prevailing during the period in which the meter failed to register.

RULES AND REGULATIONS

- L. The District shall make all reasonable efforts to eliminate interruption of service and when such interruptions occur will endeavor to re-establish service with the shortest possible delay. When the service is interrupted all consumers affected by such interruption will be notified in advance whenever it is possible to do so.
- M. The premises receiving a supply of water and all service lines, meters and fixtures, including any fixtures within said premises, shall at all reasonable hours be subject to inspection by the District.
- N. Piping on the premises of a customer must be so installed that connections are conveniently located with respect to the District lines and mains. The customer shall provide a place for metering which is unobstructed and accessible at all times.
- O. The customer's service line shall be installed and maintained by the customer at his own expense in a safe and efficient manner and in accordance with the District rules and regulations and with the regulations of the Department of Health.

RULES AND REGULATIONS

P. Billing:

- (1) The responsibility for payment of water bill for services rendered rests with the consumer receiving service and in whose name the utility has the account, absent other arrangements agreed to in writing by the landlord-owner.

In situations wherein the above rules are not applicable, the current rules and regulations governing the service of water utilities, adopted by the Public Service Commission of Kentucky, shall govern.
