<u>6 - Inch Connections</u> First 100,000 Gallons Over 100,000 Gallons	\$178.80 Minimum 1.54 Per 1,000

The monthly charge for water usage in excess of the respective minimum water rates set out above shall be computed in increments of 10 gallons. Accordingly, a customer having a 5/8 inch meter who consumes at least 2,001 gallons of water and not more than 2,010 gallons of water in any month shall pay the amount of \$8.31 for the month (\$8.28, plus 3¢). A customer having a 5/8 inch meter who consumes at least 2,011 and not more than 2,020 gallons of water in any month shall pay the amount of \$8.33 for that month (\$8.28 plus 5¢).

The foregoing rates are rates to be charged by the District, and any applicable State Sales Tax and School Tax shall be added to each bill.
