DEPOSITS

The LaRue County Water District No. 1 may require all customers to pay equal deposits in the amount of \$35.00 to secure payment of bills. Service may be refused or discontinued for failure to pay the requested deposit. Interest, as prescribed by KRS 74.055, will be paid annually by credit to the customer's bill.

Upon termination of service, the deposit, any interest earned and owing will be credited to the final bill with any remainder refunded to the customer.

In determining whether a deposit will be required or waived, the following criteria will be considered.

1. Current customers payment history with the Water Company.
2. Customers with upstanding credit, which were on the water system before deposits were required.
3. When a deposit has been waived or has been returned and the customer fails to maintain a satisfactory payment record, the utility may require that a deposit be made.
4. Whether the customer owns the property.
5. Whether the customer has filed bankruptcy proceedings within the last seven years.

The Water District's customers will be notified that after 18 months, at their request the Water District will recalculate their deposit every 18 months based on actual usage of the customer. If the deposit on account differs from the recalculated amount by more than \$10.00 for a residential customer, or by more than 10% for a non-residential customer, the Company may collect any underpayment and shall refund any overpayment by the customer to the customer's bill. No refund will be made if the customer's bill is delinquent at the time of the recalculation.
