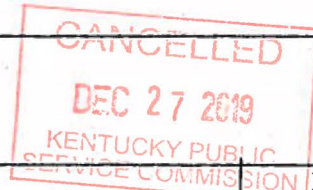

ORDINANCE NO. 19, 1982

AN ORDINANCE RAISING WATER AND SEWER CHARGES BY THE CITY OF CARLISLE AND PROVIDING A PENALTY FOR LATE PAYMENT THEREOF

Be it ordained by the City of Carlisle, as follows:

That beginning with all bills sent or due after June 30, 1982, all water customers of the City of Carlisle, shall pay the following rates for water:

WATER RATES

First 1,000 gal. for minimum bill	\$4.00
Next 4,000 gal. at	\$1.40
Next 5,000 gal. at	\$1.35
Next 5,000 gal. at	\$1.15
Next 10,000 gal. at	\$1.05
Next 75,000 gal. at	.95
Next 100,000 gal. at	.85
Next 300,000 gal. at	.80
Next 500,000 gal. at	.75

The rate for all water hauled from the water plant is \$4.00 per 1000 gallons.

All water customers shall pay at least a minimum charge per month of \$4.00. All sewer customers shall pay a monthly sewer charge in an amount equal to one-half of their monthly water bill. The City Clerk shall so bill said customers.

A penalty of 10% of the bill will be assessed on all amounts not paid by the due date, which due date is 10 days after the bill is postmarked.

This ordinance shall take effect immediately upon its passage and publication as provided by law. All previously passed ordinances or parts thereof setting water charges are hereby amended to the extent set out herein.
