

THIS ADDENDUM, made and entered into this 12th day  
of November, 1991, by and between -

THE CITY OF BARDSTOWN, KENTUCKY, a municipality  
located in Nelson County, Kentucky, hereinafter called  
"City", and

NORTH NELSON WATER DISTRICT, situated in Nelson  
County, Kentucky, hereinafter called "District".

WITNESSETH:

WHEREAS, the parties to this addendum are the same  
parties as set out in a certain agreement styled "Water  
Purchase Contract" of date October 10, 1967, and also a first  
addendum to said contract dated January 8, 1974, and a second  
addendum to said contract dated December 31, 1975, and a  
third addendum to said contract dated March 1, 1978, and a  
fourth addendum to said contract dated December 1, 1984, and  
a fifth addendum to said contract dated June 15, 1989, and  
a sixth addendum to said contract dated January 1, 1991, and

WHEREAS, the parties to this contract are now  
desirous of amending a portion of the terms contained in the  
original contract and first, second, third, fourth, fifth, and sixth  
addenda, which is agreeable to the parties hereto  
under the conditions specified according to the prior  
addenda.

NOW THEREFORE, for and in consideration of the  
Covenants and agreements hereinafter contained, the parties  
hereto agree and do hereby amend those paragraphs and

sections of the aforementioned agreement by the inclusion of new paragraphs and/or sections and/or changing the whole and/or in parts existing paragraphs and sections thereof, which contract shall from and after the effective date of changes therein, read as if contained in the original agreement with the following exception:

1. The parties hereto agree that the contract and agreement between the parties including all addenda to said contract or agreement shall be for a term of forty-five (45) years from October 1, 1991.

2. All other terms, conditions, rates, and agreements between the parties shall remain in full force and effect with the exception of the term of the contract as is set forth in paragraph 1 above.

3. This contract is hereby pledged to Farmers Home Administration for security on the loan for North Nelson Water District, Phase IV improvements.

IN WITNESS WHEREOF, the parties hereto acting under authority of their respective governing bodies have caused this addendum to the Contract aforesaid to be duly executed in three counter parts each of which shall constitute an original.
