RULES AND REGULATIONS

C. Payment of Bills.

1. All bills become due when rendered. The net amount is payable from the first (1st) through the tenth (10th) of the month. The gross amount becomes due after the tenth (10th) of the month. A non-payment penalty will be added to the gross bill after the twentieth (20th) of the month equal to ten percent (10%) of the minimum monthly bill.
2. Bills may be paid at the DISTRICT office, by mail, by banking service, or at any of the collecting substations listed on the water bill; provided, however, that no bills paid after the tenth (10th) of the month and no adjusted or corrected bills may be paid at a collecting substation.
3. Payments by mail which are postmarked on or before the tenth (10th) of the month will be accepted for the net bill regardless of the date received. The postmark on the envelope will be deemed conclusive in all cases of payment by mail.
4. In the event the tenth (10th) of the month occurs on a Sunday, a holiday, or any other day when the DISTRICT office is closed, payment of the net bill will be accepted through the next working day. Payments by mail postmarked on the next working day will also be entitled to pay the net bill.
5. Bills not paid by the twentieth (20th) of the month are considered delinquent. Payment reminder letters will be promptly mailed to all delinquent customers. If the bill remains unpaid after the twenty-fifth (25th) of the month, water service will be discontinued and the customer's meter will be removed after 48 hours written notice is given to the
