RULES AND REGULATIONS

The following rules and regulations are subject to change by the Water District Commissioners at any time subject to approval by the Public Service Commission.

1. Returned Checks. A \$5 service charge will be charged to each customer for each returned check.
2. Meter Test Request. Upon request a customer may have his meter tested and adjustments will be made to the bill where the meter is found to be wrong. If such test shows the meter to be in working order a \$25 charge shall be made.
3. A charge of \$5 shall be made any time the meter reader has to go out to collect a bill.
4. If the meter is removed for non-payment a \$10. charge shall be made.
5. Meter Reading Recheck. A charge of \$5 shall be made for a trip to recheck a meter reading when the customer requests the meter to be rechecked for a correct reading and the meter was not misread.
