WEST CARROLL COUNTY WATER DISTRICT

RULES AND REGULATIONS

Section 5. If the water service of any customer is disconnected after non-payment of the water bill, the District shall require payment of \$10.00 reconnection charge and payment of delinquent water bill or bills in full before reconnection is made.

Section 6. The fee for reestablishing a discontinued service for a customer (other than a delinquent customer) shall be \$10.00.

Section 7. ~~*A rental deposit of \$25.00 shall be required of all rental customers. This fee to be deposited in an Escrow account and refunded to the customer when they move. Interest shall be paid at the rate of 6% annually to the customer.~~

Section 8. The fee for collecting delinquent water bills shall be \$10.00.

Section 9. The rates herein established shall be effective beginning October 1, 1977, subject, however, to approval of the Public Service Commission of Kentucky. All rules and regulations of the Public Service Commission shall be deemed a part of this Rate Resolution to the extent applicable, the same as it set out in full herein.

Section 6. Footnote.

Any customer wishing to have meters removed, to prevent freezing or vandalism, while the property is vacant due to vacation, moving and etc., a fee of \$10.00 shall be charged to reinstall meter. This fee being necessary to cover part of the expense incurred by the District to hire someone to replace meter. No full-time maintenance man is employed at this time.
