SERVICE CHARGES:

All Returned or Bad Checks 10.00

A charge of \$10.00 will be added to a customers account for every check every time a check is returned or bad. The customer will be notified of the amount due by a certain date. If it is not paid by the due date, water service may be disconnected with no further notice.

Reconnection Fee 15.00

A reconnection fee of \$15.00 will be added to a customers account every time water service is locked or turned off. If it is discovered that this service has been reconnected without Whitley County Water District's authorization, the service will be disconnected again. A reconnection fee will be charged each time this occurs. A lock fee will also be charged if any part of the lock is damaged. The estimated or actual cost of water used will also be charged. All charges are required to be paid in full before the Whitley County Water District will reconnect water service.
