2. Any resident of Wood Creek Water District is eligible for water service from the District.
3. Water service will be terminated within 12 hours after receiving a written request from the customer requesting discontinuance.
4. All new applications for service shall be accompanied by a \$20.00 deposit to assure payment of bill.
5. A fee of \$5.00 will be charged for re-connection of service.
6. Water connection and installation fees for each individual customer will be \$150.00.
7. Bills must be paid within ten (10) days after receipt, upon penalty of discontinuance of service.
8. Meters will be reading the last week of each month, and statements mailed before the 10th of each month.
9. Service lines to meters and meters are property of the District. From meter to customer outlet installation and service will be sole responsibility of customer.
10. All meters will be located on district mains and in the absence of special permission on the property to be served. Reference is made to a more detailed explanation contained in the By-Laws.
11. Complaints may be made to the Water District Office at 122 West First Street, London, Kentucky and may be appealed to the district commission within 10 days.
12. The principal place of business of the district will be at the Water District Office at 122 West First Street, London, Kentucky.
13. Water bills shall be paid at 122 West First Street, London, Kentucky.
