B. Meter Rates for Water Usage in Addition to Minimum Charge

Subject to the minimum monthly water rates specified above, the following metered charges shall be made for each 1,000 gallons of water consumption per month to customers of all size connections:

First 2,000 gallons	\$ 8.60 (Minimum Bill)
Next 1,500 gallons	2.70 per 1,000 gallons

Over 7,500 gallons	1.55 per 1,000 gallons
Wholesale Rate	1.05 per 1,000 gallons
