**PETITION FOR A CERTIFICATE OF
PUBLIC CONVENIENCE AND NECESSITY**

America's Digital Satelite Telephone, Inc. ("ADST"), by its undersigned counsel and pursuant to Section 278.020 of the Kentucky Revised Statutes, Ky. Rev. Stat. Ann § 278.020 (1998), hereby submits its petition for a Certificate of Public Convenience and Necessity to provide resold interexchange telecommunications services within the State of Kentucky, including direct-dialed 1+ telecommunications services and calling card services. In support thereof, ADST provides the following information:

1. Petitioner's legal name, and the name under which Petitioner will provide telecommunications services in Kentucky, is America's Digital Satelite Telephone, Inc. Petitioner maintains its principal place of business at:

2. ADST is incorporated under the laws of the State of Nevada. A copy of Petitioner's Articles of Incorporation is attached as Exhibit A. A copy of ADST's Authorization to transact business in Kentucky is attached as Exhibit B.

3. ADST proposes to provide 24-hour intrastate common carrier telecommunications services on a statewide basis to its subscribers. ADST's initial intrastate services will include 1+ and calling card services.

4. Petitioner will operate as a switchless reseller, and intends to purchase capacity from underlying facilities-based carriers and make service available to its customers.

5. ADST plans to provide telecommunications services to its subscribers to and from all points in the State of Kentucky and, therefore, seeks statewide certification.


6. ADST does not seek to provide operator assisted services to traffic aggregators as defined in Kentucky Administrative Case No. 330.

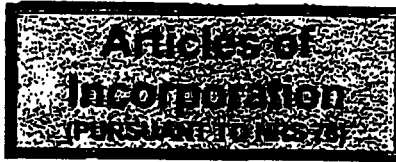

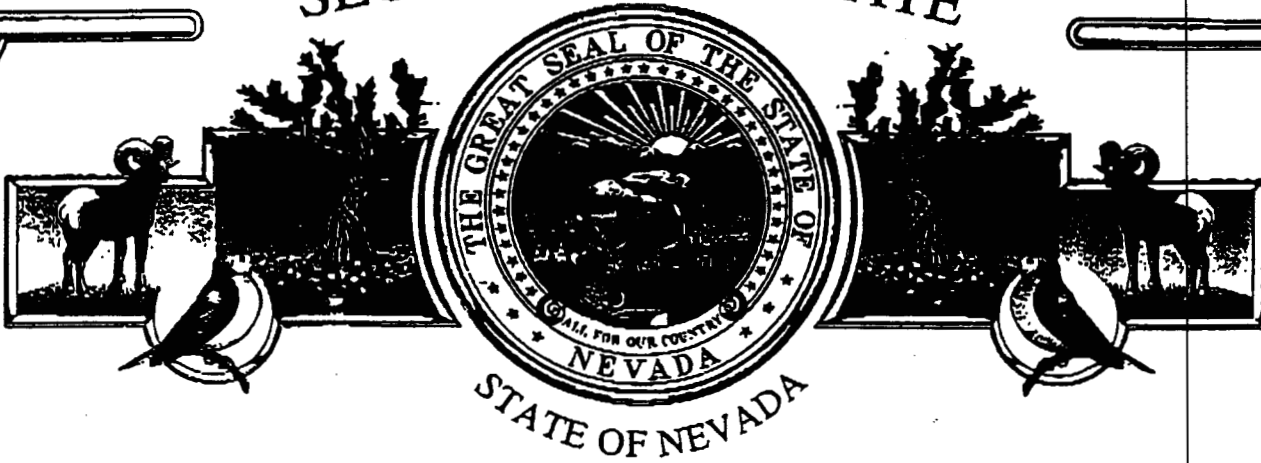
